

Regulations of the fair



GLOSSARY OF TERMS

FAIR – PROMO SHOW, taking place on February 14-15, 2024 at EXPO XXI Warsaw, Prądzyńskiego 12/14.

ORGANIZER - OOH magazine Al. Roździeńskiego 86A / IIIC, 40-203 Katowice.

EXHIBITOR - a company with a fair exhibition during the fair.

VISITOR - a person visiting the fair.

GENERAL PROVISIONS

1. These Regulations define the conditions of using the Organiser's services during the Fair.
2. The duration of the fair:
(Wednesday) February 14, 2024.
(Thursday) February 15, 2024.

VISITOR

1. Opening hours of the fair for visitors:
February 14, 2024 from 10:00 a.m to 5:00 p.m.
February 15, 2024 from 10:00 a.m. to 4:00 p.m.
2. Visitors must register for free at www.promoshow.pl. In the form registration, you must fill in all the fields - it is necessary for the correct completion of the proces registration. Failure to complete all the items in the form may cause the process to fail registration.
3. After sending the online registration, the visitors will receive a confirmation by e-mail. Registration is invalid without confirmation by e-mail.
4. Registration on the website will last until February 15, 2024.
5. Visitors are prohibited from submitting offers to Exhibitors and other fair participants and distributing them advertising materials under pain of having to pay a fee of PLN 5000.
6. Only adults are allowed to enter the fair.
7. The ORGANIZER reserves the right to ask disruptive visitors to leave the fairgrounds order, behaving bothersome, under the influence of alcohol or intoxicants.

EXHIBITOR

1. Exhibition opening hours for Exhibitors:

February 14, 2024 from 8:00 a.m to 5:00 p.m

February 15, 2024 from 9:00 a.m to 4:00 p.m

2. Exhibition assembly hours for Exhibitors:

Monday / February 12, 2024 from 10:00 a.m to 10:00 p.m

Tuesday / February 13, 2024 from 8:00 a.m to 10:00 p.m

3. The exhibition is disassembled on February 15, 2024 from 4:00 p.m until midnight.

4. The ORGANIZER is not responsible for interruptions in the supply of utilities or services caused by circumstances independent of him. In such a situation, he undertakes to take all necessary measures to restore unimpeded access to media and services.

5. Fair participants (exhibitors) are fully responsible for health and safety at work of their employees performing work on the fair grounds and are responsible for any resulting accidents due to lack of supervision or neglect of work safety requirements and standards during the fair.

6. The Exhibitor undertakes to comply with all regulations in force at the venue events, especially fire and health and safety.

7. It is forbidden to hang and stick any advertising elements outside the stand, as well as elements not agreed with the ORGANIZER.

8. It is forbidden to block communication routes and emergency exits. Equipment unloading the stand may only take place within it, without blocking other exhibitors.

9. It is forbidden to block access roads and fire-fighting roads, and in case of immediate failure, not removal of vehicles (or other blocking items) at the request of the Organizer or the owner of the facility, there is a risk of a fine of PLN 500.

10. Removal of the exhibits before the end of the fair is prohibited. These steps can be started only after the fair closes to visitors on the last day of the fair.

11. Exhibitors are not allowed to promote third parties at the stand without the Organiser's consent.

12. The Exhibitor undertakes to respect and not infringe the rights of other exhibitors, in particular for disrupting order, playing music or advertising loudly. Documentation above violations entitles the Organizer to terminate the contract with immediate effect, whereby Exhibitors undertake to make every effort to resolve any disputes on the road amicable.

TRANSPORT AND UNLOADING

1. Transport, unloading, unpacking, assembly, disassembly, packing and loading of exhibits are performed by the Exhibitor at his expense and risk. The organizer is not responsible for items left at the stands during disassembly and after the end of the fair.

WITHDRAW FROM THE AGREEMENT & COMPLAINTS

1. The Exhibitor has the right to withdraw from the contract without giving any reason within 14 days from the date of receipt the confirmation of acceptance of the application for implementation, but not later than 60 days before the PROMO SHOW fair (which takes place on December 16, 2023).
2. Contracts concluded for a period shorter than 60 days before the fair cannot be withdrawn, and the Exhibitor is obliged to pay the Organizer all the amounts due under the contract.
3. Complaints regarding the construction of stands and technical equipment should be reported in writing to the Reception of the Fair by 9:00 on the first day of the fair at the latest.
4. Other complaints should be submitted to the Organizer in writing with attached photographic documentation no later than within 14 days from the end of the fair. After this deadline, the complaint will not be considered.

FINAL PROVISIONS

1. The ORGANIZER is entitled to terminate the contract without notice in the event of gross failure violation of the provisions of the contract by the Exhibitor, in particular:
 - failure to settle any amounts due to the Organizer,
 - subletting or handing over the stand to third parties,
 - nuisance behavior.
2. It is forbidden to bring weapons, ammunition and explosives to the fairgrounds and items the use of which may endanger the safety of people on the premises fairgrounds.
3. Contests and lotteries may be organized after obtaining the Organiser's written consent and with the compliance with the requirements resulting from the relevant regulations.
4. The ORGANIZER is not responsible for the protection of trademarks, patents, etc. exhibits presented at the fair.
5. Each person registering and visiting the fair confirms that they know the regulations of the fair and agrees to receive commercial information from the Organizer by electronic means.
6. The ORGANIZER provides general security of the fair grounds, however, does not bear any responsibility for damages and losses in exhibits. It is recommended to secure the stands after the end of the fair day e.g. by foiling them.
